



CONDITIONS OF ENTRY

NZ CUP MEETING 2021

CANTERBURY JOCKEY CLUB INCORPORATED

TICKETS SOLD AND ENTRY TO THE NZ CUP MEETING TO BE HELD ON SATURDAY 6, WEDNESDAY 10 AND SATURDAY 13 NOVEMBER 2021 AT RICCARTON PARK RACECOURSE ('THE RACECOURSE') ARE SUBJECT TO THE FOLLOWING CONDITIONS:

- The Canterbury Jockey Club Incorporated ('CJC') reserves the right to refuse entry.
- No person under the age of 18 years will be admitted to the racecourse on NZ Cup Day.
- Intoxicated people will be refused entry. Random breath testing may apply.
- To be served with alcohol, all patrons in General, Members and Corporate areas on NZ Cup Day, Saturday 13 November 2021 are required to wear the wristband as provided at gate entry
- In managing intoxication levels, the CJC reserves the right to refuse serving alcohol to person/s, remove their wristband and remove them from the racecourse.
- Patrons are not permitted to carry alcohol onto the racecourse. Alcohol cannot be brought into the racecourse in vehicles and searches of vehicles may be conducted.
- Pass outs will be not be issued on NZ Cup Day.
- Patrons are admitted to the racecourse at their own risk.
- There are no ticket refunds excepting any related to Government or Racing Industry imposed COVID-19 implications.
- Any items which are regarded as offensive or items which can be used as a projectile are prohibited and may be confiscated.
- Patrons, their bags, and clothing may be searched on entry to the venue. Patrons who refuse inspection may be denied entry to the racecourse.
- Smoking is prohibited in all indoor areas, including marquees.
- Commercial food and external catering operations (excepting those authorised food vendors) will not be allowed access to the racecourse. Small amounts of food for personal consumption are permitted to be brought onto the racecourse by pedestrian patrons.
- CJC Board, Management and their representatives will take no responsibility for confiscated items.
- Patrons are not permitted into the Birdcage, Parade Ring, Tie-up Stalls, the Jockeys Room area or onto the racetrack Course Proper and areas inside that at any time.
- Advertising material and promotions are not permitted on the racecourse unless expressly authorised by the CJC in writing. Any unauthorised advertising and promotional material including product giveaways will be confiscated.
- Patrons bring personal items onto the racecourse at their own risk. The CJC will not be held responsible for any damages to, loss of, or theft of a patron's personal property.
- All photographs of patrons taken at the racecourse by contractors and photographers appointed by the CJC become the property of the CJC and may be used for future advertising and publicity purposes.
- When you purchase event tickets the CJC is collecting and storing personal information about you. This personal information may be disclosed to the TAB New Zealand from time to time for promotional, marketing and research purposes. Pursuant to the Privacy Act 1993, you have the right to view and correct personal information held by the CJC.
- Ticket-scalping protections as per Major Events Management Act 2007 and any offences and breaches of such will apply. No person may, without the authorisation of CJC, sell or trade a ticket to the NZ Cup Meeting 2021 for a value greater than the original sale price of that ticket.

PATRONS ARE PROHIBITED FROM BRINGING THE FOLLOWING INTO THE RACECOURSE:

- Alcohol.
- Open drinking containers.
- Opened or unsealed Soft drink containers.
- Unsealed or unclear bags of ice.
- Animals (except service animals or assistance animals under the NZ Public Health & Disability Act)
- Flags, banners & signs with handles exceeding 1.8m.
- Unauthorised musical instruments, amplification equipment, air horns / loud hailers.
- Drones, Flares, fireworks, and laser pointers.
- Bicycles, skateboards, rollerblades, roller skates and scooters.
- Unauthorised political, religious or offensive items of whatever nature including clothing, banners, signs, leaflets, or flyers.
- Dangerous goods and anything that could be used as a weapon.

ALCOHOL POLICY

- In accordance with our host responsibilities under the Sale and Supply of Alcohol Act 2012, liquor will not be served to;
- Minors (persons under 18 years) and Intoxicated Persons.
- Intoxicated people will be removed from the Racecourse.
- Intoxicated people will be refused entry. Random breath testing may apply.
- Patrons agree to abide by the Alcohol Ban surrounding the racecourse.

SMOKING POLICY

- Smoking is not permitted in all indoor areas, including marquees.

ACCESS TO CORPORATE AREAS

- A valid ticket and a tidy standard of dress are required to obtain access into a corporate area.
- Access will be denied to persons under 18 years unless accompanied by a parent or guardian.

CAR PARKING POLICY

- No vehicles will be allowed access to the course until 10am on NZ Cup Day.
- All vehicles may be subject to alcohol checks.

GRAND NATIONAL STAND

- This grandstand is again closed for use across all 3 days of the Meeting
- Customers utilising this facility in previous years will be accommodated via temporary infrastructure.

PROHIBITED CONDUCT

For the comfort and safety of patrons, horses and officials, the following conduct is NOT permitted by the CJC without their express authorisation:

- Conduct towards any jockey, trainer, owner, staff, race day official or another patron in a manner which offends, insults, humiliates, intimidates, threatens, disparages, or vilifies that other person.
- Disruption or interruption to any race or other event activity at the racecourse.
- Act in a manner that may startle, spook, distract, interfere with, endanger, or cause harm to any horse present at the racecourse or, to any person in proximity to any horse present at the racecourse
- Damaging or defacing or any part of the racecourse or any other person's property.
- Unreasonable disruption or interference or obstruction to patrons or other persons engaged in the operation of the NZ Cup Meeting 2021 race-meetings.
- Conducting public surveys or opinion polls, soliciting donations or subscriptions, other commercial or political disruption.
- Transferring a ticket or wristband that has already been used for entry to the NZ Cup Meeting 2021.
- ball games of any kind.
- removal of footwear, shirts, or public nudity / indecency.
- concealing identity with a scarf, balaclava, mask, or other item unless for a religious, medical, or other justifiable reason.
- smoking in non-smoking areas (inside rooms and otherwise where signed).
- conduct which amounts to an offence under Major Events Management Act 2007.
