## **CANTERBURY RACING PUNTERS CHALLENGE SATURDAY 15 APRIL 2023**

### **RULES & CONDITIONS**

1. Names of contestants to be disclosed although a nom de plume may be used for publicity purposes.
2. \$500 betting funds to be deposited with the Canterbury Jockey Club ('CJC') by Thursday 6 April 2023 at 5 pm in cash or certified bank cheque unless special arrangements are made.
3. Minimum of \$50.00 to be invested on each race commencing with Race 1. This applies even if there are ten (10) races or more. There is no maximum.
4. Once funds have been used no additional monies can be added.
5. If the balance is less than \$100.00, the entire amount shall be invested.
6. A bet in any given race must be placed at least five minutes prior to the start of the race. Failure to comply with this Rule will result in the CJC investing \$100 on the win favourite at the time on the contestants' behalf.
7. In the event of an enquiry which is not resolved prior to five minutes before the start of the next race, any contestants whose funds are held up because of the enquiry and who has less than \$100.00 of funds available, shall not be disqualified but shall resume investing on the race after the inquiry has been resolved.
8. All bets to be placed on Saturday 15 April 2023 at the CJC racemeeting. The bet types which cannot be placed are Multi bets, Pick Six, Place6, Six Pack and Triple Trio. Fixed odds betting is not available within this competition.
9. Contestants must complete bet slips themselves and take full responsibility for any error which may occur on them.
10. No CJC fulltime employee or Board Member may enter.
11. A progress chart showing each contestant's name (or nom de plume) will be updated following each race as soon as possible after results are confirmed.
12. The winner shall be the contestant with the highest balance after dividends of the last race at the CJC have been added to the contestant's deposit ticket.
13. The individual balance and pay out of amounts earned will be available as soon as possible after the last race is confirmed. Every endeavour to pay out final funds in cash will be made, however contestants must accept that either TAB cheques or deposit slips may have to be given.
14. A presentation will be made to the winning contestant after the last race.
15. In the event of a tie, the winner shall be drawn by lot under the supervision of an RIU Investigator or Stipendiary Steward.
16. If, for any reason, the race meeting is postponed or abandoned, the contestant who has the highest balance at the time the meeting is stopped shall be declared the winner.
17. Syndicates are limited to a maximum of five (5) persons. There are no exceptions to this rule
18. Each entry/syndicate has a maximum of five persons. Each individual contestant is required to pay \$80 each by Thursday 6 April 2023 at 5 pm to enter the room. This \$80 includes a Buffet Meal, beer, house wine and juice. The bar closes 30 minutes after the last race.
19. The CJC reserves the right to cancel this competition and refund money in full if less than 30 entries are received or vary the prize money to \$2000 and 2 x \$250 runners up prizes.
20. A maximum of 75 entries will be taken on a first-come, first-served basis.
21. Each contestant or syndicate will designate only one person to hand the completed bet slip to the operator of the betting terminal. The operator will then place the bets for the contestant.
22. All contestants must be in the designated area thirty (30) minutes before the first race
23. The winner(s) will receive a cash prize of \$4,000. Second prize winner will receive \$500 cash and 3rd \$500 cash. (Excepting item 19 above)
24. Contestants accept that as the winner their nom de plume may be used for publicity/media purposes.
25. Full payment of both \$500 betting funds and \$80.00 per head room entry may be made to Canterbury Jockey Club, Riccarton Park Racecourse, 165 Racecourse Road, Christchurch 8042, PO Box 11-137 Christchurch 8443 by 5pm on Thursday 6 April 2023.
