CHAIRMAN'S REPORT



For the past two years I have started my report by stating how extraordinary each year was. Incredibly the 2021/22 season surpassed each of the 2019/20 and 2020/21 seasons.

After an extremely positive start to the year with a Grand National Festival of Racing that exceeded expectations, New Zealand went into a Covid-19 enforced lockdown on Tuesday 17 August 2021 at what was known at the time as Alert Level4.

Level4 remained in place for Canterbury until Tuesday 7 September 2021. Due to time passing before there was clarity as to the Club's ability to have staff working to maintain the racing surface, the first day of the Spring Racing Season scheduled for Saturday 4 September was transferred to Ashburton. This was because the Grand National Festival was run on extremely heavy ground and time repairing it was lost prior to authority being granted to allow staff to come to work.

Alert Level2 came into play on 7 September and lasted through to Thursday 2 December 2021 when the Alert Levels were replaced with the Covid-19 Protection Framework which became commonly known as 'Traffic Lights'. Canterbury was placed in the 'Orange Traffic Light' but prior to the 2nd day of the Summer Season changed to 'Red' with restrictions again imposed on attendance until reverting back to 'Orange' prior to the racemeeting on Saturday 23 April in which state it remained until Monday 12 September 2022.

Unfortunately, in the period from 7 September to 2 December 2021 the Canterbury Jockey Club had to conduct its racemeetings with isolated groups of no more than 100 people indoors and 200 outdoors as was permitted under Alert Level2. This had a massive impact on attendance and financial returns at the 2021 New Zealand Cup Meeting.

The Club was able to host 1,000 people on the first day, 1,300 people on the second day and 1,500 on New Zealand Cup Day. The latter vastly different from the 15,000 sell out attendance of previous years.

The various Covid-19 restrictions also impacted adversely on the Riccarton Park Function Centre with many events cancelled or forced to take place with restrictions on attendance and conditions such as being seated and served.

To enable the Club to conduct business as best as able the Board on Friday 19 November 2021 resolved to operate its events, racing and non-racing, with the requirement of vaccination certificates. This was in response to Government and Crown Health mandates and to have not done so would have meant that no-one would have been able to attend anything conducted by the Club.

Running racemeetings and non-racing events in this manner placed intense pressure on the management and staff of the Club and I applaud them all for working in these restrictive conditions.

This position was reversed at the April Board meeting after the Government announced that vaccine passes would not be required from Tuesday 5 April 2022.

I would like to specially mention the support of our sponsors without whose contribution the Club would have suffered a more serious financial downturn. Many undoubtedly suffered financially in their own business and possibly had reason to reduce sponsorship or defer until better times but chose not to and continued to support racing at Riccarton Park. On behalf of the Board, members, and all racing stakeholders I thank you for that support.

The Riccarton Park Polytrack came into use on Thursday 12 August 2021 for training. The first Trials meeting took place on Tuesday 5

October 2021 when 74 horses competed in 16 heats. A further nine sets of Trails have taken place since then to Tuesday 6 September 2022.

The first racemeeting was conducted on Thursday 5 May 2022 with a formal opening and blessing by Ngai Tahu prior to the first race. That was the first of an eleven meeting Polytrack season taking place fortnightly up to Wednesday 17 September 2022. Once again, I want to thank the Trustees of the Christchurch Racecourse for their financial contribution without which the Synthetic Racetrack would not have been built.

Dianne Logie succeeded Bill Cotton as Treasurer and she will explain the financial results from the 2021/22 season and the financial position of the Club in her report further on in this document.

The Board has applied for consent to demolish the Grand National Stand and after a period of public notification which drew objections, the Club and its legal support, Chapman Tripp, attended a hearing on Thursday 1 September 2022. It is hoped that a decision by the Commissioner will be delivered before the Annual General Meeting.

As reported in last year's report on Wednesday 30 June 2021 the Club was advised that Racing New Zealand had decided to undertake a review of the racecourses in the northern half of the South Island. Including racing activities of all three codes. This review was undertaken and released on Tuesday 12 April 2022. The report will have a major influence on the future use of Rangiora Racecourse as a key recommendation is that "Rangiora is wound up and the codes use the proceeds to invest in measures to help sustain racing in Canterbury". A meeting was held on Tuesday 13 September 2022 with representatives of the Club, New Zealand Thoroughbred Racing, Harness Racing New Zealand, and the Rangiora Harness Racing Club to discuss the content and recommendations of the report. There were no formal decisions reached at this meeting. NZTR does not have racing at Rangiora in its venue plan and HRNZ is to determine its position on what it sees as the future for Rangiora Racecourse.

Sadly, I must acknowledge the passing of Board member Matt Standing on Tuesday 23 November 2021. Matt was a valued member of the Board, and his passing was deeply felt by all at the Club.

I want to thank on behalf of the Board the four ward Committees who so ably run their allocated racedays, that is Amberley, Hororata, North Canterbury and Riccarton Turf.

I also thank the Trustees of the Christchurch Racecourse under Chair Peter Cordner and acknowledge with sympathy the passing during the year of Trustee and former CJC Board Member Clive McCall and acknowledge the retirement in June of Trustee and former Club Chair and Treasurer George Ritchie. Both men made significant contributions to the Club, Trustees and racing here at Riccarton Park.

Thank you also to all the staff of the Canterbury Jockey Club and Riccarton Park Function Centre who prepared and maintained the racing operations and promoted and ran events at the racecourse in what was a most challenging Covid-19 dominated first two thirds the year.

I conclude my report by advising you that this will be my last full season as Chairman but have offered myself for re-election to the Board. Wendy and I wish to sincerely thank Chief Executive Tim Mills, his executive team, and staff for the fantastic support they given us over the past five years. My grateful thanks also to the CJC Board for their support and expertise. We look forward to contributing to and enjoying Canterbury Racing in the future.

TREASURER'S REPORT



It is a privilege to write my first report for our members. I was appointed Treasurer after the 2021 AGM at the first Board meeting on 14 October 2021.

At the time of this appointment, the Club had held a successful Grand National Festival, to then be quickly put back into lockdown. The 2021/22 season saw COVID-19 impact our Club, like many other businesses, heavily. The ability for both our racing and Riccarton Park Function Centre (RPFC) operations to operate effectively and efficiently hampered by various Government restrictions. These restrictions, which included maximum group sizes of 100 affected not only our racing operations but also the RPFC businesses; and our ability to operate both effectively and efficiently.

As in previous years, it is necessary to "interpret" the provided Statements, which conform to the strictures of the reporting requirements of the New Zealand Accounting Standards Board. In particular, it is necessary to distinguish the normal operating surplus from "one off" non-operating income.

The following is a highly summarised interpretation of the Statement of Comprehensive Revenue and Expense for the year ended 31 July 2022.

To operate with a small deficit of \$30,000, I believe is an acceptable position when the Club has been so heavily restricted in its ability to operate normally. This result has been achievable through the Club accessing all government financial assistance available to us during the year and the continued support of our governing body, along with sound financial decisions from our Chief Executive and his senior management.

Racing Operations

The most obvious area of racing where we were unable to operate was at our NZ Cup Meeting where we would normally have up to 15,000 attending New Zealand Cup Day and the numbers attending due to constraints of operating at Level 2 were across the 3 days 983, 1278 and 1544. We were incredibly fortunate to be able to still provide paid hospitality areas across these three days as this provided much needed revenue and emphasises the importance of race day hospitality for our business.

In August 2021 the synthetic track was completed and used for training and trials since that date. In May 2022 the track officially opened and has been used for racing since then. The development of this synthetic track is a significant asset for our club, firstly by allowing us to run more race meetings particularly in the Winter and allowing trials at Riccarton Park which reduces travel to other venues for our stakeholders. Racing operation have provided a significant contribution of \$1,464,218 this year (2021: \$1,361,076) which includes total stakes paid to owners of \$7,700,007 (2021: \$5,718,978).

I would like to thank the work of Commercial Manager, Chris Rowe, in continuing to maintain the support of our sponsors, who although were unable to enjoy their usual privileges still provided revenue of \$572,084 (2021: \$644,028)

RPFC Operations

The RPFC is an incredibly important part of our business, and with the COVID-19 restrictions covering some eight months of the financial year this area lost significant sources of revenue and incurred additional expenses to meet government requirements. The RPFC had a contribution of (\$130,860) (2021: \$280,369). At the time of writing, the interest in our venue and bookings is surpassing expectations and we are hopeful that this will be a very profitable year.

Although the Operations Manager, Eric Cormack, and Hospitality Manager, Phil Leabourn, had to deal with increasing compliance and uncertainty; their attitude to adapt and meet the changing requirements is commendable and changes that were made during this time will hopefully increase the profit-making ability in the future. My thanks to them and their team for their efforts in what was a very stressful time.

TREASURER'S REPORT

In the horizon

We are still working through issues resolving the future of the Grand National Stand. There was a hearing on 1 September 2022 to resolve the application for a building consent to demolish the Grand National Stand. The outcome of this hearing will have a considerable impact on the Club's finances. Should the consent be granted there will be significant costs to demolish the building and prepare the site for immediate use and for potential future facility construction. We know that we must ensure the financial viability of all decisions that are made in relation to this project to ensure the best outcome for the Club and racing in the future.

We continue to invest in Riccarton Park as a strategic training centre, and this can be seen through the recent upgrade of training tie-ups, and will continue to ensure that we can attract new trainers to the course to increase training numbers. The increase in depreciation expense is attributable to the Polytrack racing surface, and reserves will need to be held to cover this cost.

The recommendation in the Sapere Report, to consolidate racing venues in the Canterbury region, mean that discussions will need to take place around the interest of our Club in Rangiora Racecourse. With racing and trialling no longer being held at this course, its value to our Club needs to be investigated.

Acknowledgement

Thank you to all of our staff who through a turbulent year, have ensured that the Club's financial performance was held in the highest regard when decisions were made. Our Chief Executive, Tim Mills, has led them impeccably.

I would like to acknowledge the work of the Business Services Team, comprising of the manager Gareth Murfitt and Julie Walsh, Assistant Accountant; who always kept the Board and Management well informed of the financial performance and position of the Club; maximising areas of funding available to ensure the Club had appropriate levels of cash flow for our day-to-day operations without calling on reserves. Finally, I would also like to thank Gordon Fulton and Wendy on behalf of the board for the tireless effort and time through some difficult situations we have had to get through over the years he has been Chairman. We are looking forward to working with Gordon as he continues his service as a Board Member.

CHIEF EXECUTIVE'S REPORT



The 2021/22 racing season was again dominated by the impact of the Covid-19 pandemic and the various procedures put in place by the New Zealand Government to combat it. The restrictions of the various Alert Levels and Protection Framework 'Traffic Lights' played havoc with the Clubs racing and events business particularly so from mid-August to

11:59pm on Sunday 2 December 2021 when the 'Orange Traffic Light' became applicable to Canterbury.

'Orange' provided greater freedom and a loosening of restrictions and allowed business to get back to a semblance of normality. The use of Q Codes and scanning Vaccine Passes were a vast improvement on the Alert Level2 restrictions. They enabled the Club to commence rebuilding its Riccarton Park Function Centre business and run racemeetings with people attending.

However, the damage had been done before then and the critical New Zealand Cup Meeting was held with attendance restrictions and a consequential massive drop in income generated. The Chairman and Treasurer provide more detail in their reports. The four Saturdays of the Spring Racing Season, 4 September (transferred to Ashburton), 18 September, 2 and 23 October were all disrupted under Alert Level2.

The virtual Annual General Meeting of New Zealand Thoroughbred Racing held in November 2021 reinforced the significance of the disruption to the New Zealand Cup Meeting not only to this Club but to racing in New Zealand. At that AGM the 2020 renewal of the NZ Cup Meeting was recognised as the 'New Zealand Racing Event of the Year' for the second year running. The Award has only been made twice.

Riccarton Park Function Centre business had ceased, planned events cancelled and uncertainty made marketing the business near to impossible.

A second blow was struck at 11:59 on Sunday 23 January 2022 when the Government imposed the 'Red Traffic Light' on Canterbury which again imposed restrictions on the numbers of people able to attend events including racedays. With some variations to allowable attendance numbers this lasted until Wednesday 13 April 2022 when all New Zealand returned to the 'Orange' setting. Six racemeetings from Saturday 29 January to Saturday 9 April were affected in this period.

I really want to pay tribute to the staff of the Club during this management of our flagship events and our Function Centre in the Covid-19 climate. To have to plan and operate for reduced participation and cancelling events was logistically challenging and truly depressing but to a person all adopted a 'Blitz Mentality' and just got on and did the job. Well done all.

New Zealand Thoroughbred Racing provided Covid-19 support funding and the Government's wage and salary subsidy helped enormously in minimising the fiscal impact of these 3½ months.

2021/22 also saw the introduction of the Polytrack to the Riccarton Park landscape. Eight additional racedays were held, an increase from the 20 racemeetings of 2020/21. Thirty-one meetings are scheduled for 2022/23. Additional meetings enhance the profitability of the Club's racing operation and reduce travel costs for the considerable number of horses trained at Riccarton Park and at private properties in close proximity.

Training was able to take place all year round with particular benefits in the winter months. July 2022 was the wettest month in the history of Christchurch and the Polytrack provided a consistent and very usable training tool when other tracks were out of action. The Club and Riccarton Park trainers now have four key tools in the training toolbox, the Polytrack, grass training track, plough and sand. Choices can be made depending on weather, season, individual horse requirements.

Eleven racedays held fortnightly from May to September comprise the Synthetic Racing Season each year and are a mix of Industry and Feature days. Horses have been able to win from anywhere in the running and favourites have a 31% strike rate which is like what is achieved on the turf.

Whilst the Polytrack is an exciting innovation it must be recorded that the best racing, the Saturday racing and meetings with Group and Listed races will continue to be run on the Turf. The Course Proper remains our main stage, our centre court.

I wish to sincerely thank all Staff, Board, Committee members, and Stakeholders for their efforts and assistance to the operation of the Club in what has been another extraordinary year. In conclusion on behalf of the Staff I wish to pay tribute to the contribution made to this Club by retiring Chairman Gordon Fulton and his wife Wendy. The Canterbury Jockey Club has a history of Chairs whose devotion and service to the Club, Riccarton Park and racing generally has been exemplary and Gordon continued that tradition.

RACING HIGHLIGHTS

The first day of the Grand National festival took place under beautiful winter conditions but on very heavy going. Southland owner trainers Kerry and Ian Taplin were probably looking to TAPPY'S ONE to win the Winning Edge Presentations Winter Cup seeing as he was running for a \$36,000 bonus after winning the Oamaru Cup but the raw emotions evident after stablemate RITANI triumphed gave no hint of that.

Racegoers were given a treat witnessing the dominant performance of the great jumper TALLYHO TWINKLETOE in the Racecourse Hotel Koral Steeplechase. The 11-year-old recorded his 14th win from only 32 starts.

If he wasn't one of the modern-day greats before the Hospitality NZ Canterbury Grand National Hurdles, THE COSSACK certainly became one afterwards. The dominant victory added the Grand National trophy to those of the Waikato, Great Northern and Wellington Hurdles previously won by the horse.

Earlier in the day Nelson and training partner Corrina McDougal had prepared NEDWIN to win the time-honoured Nautical Insurance sponsored Duke of Gloucester Cup for the Amateur Riders. Leah Zydenbos was aboard.

Six years ago, TALLYHO TWINKLETOE won the Grand National Hurdles at Riccarton Park. He jumped into racing folklore with a massively brave win in the Racecourse Hotel & Motor Lodge Grand National Steeplechase. In between times he had won the Australian versions of the Grand National Steeplechase and Hurdle and appears to be the only horse to have achieved this Australasian double. Master trainer Kevin Myers prepares the 11-year-old but the stable referred all praise to part owner Jo Rathbone who had been looking after the gelding for the Festival. Shaun Phelan took the mount and now stands alone with the most wins by a jockey in the race with four. In mid September Art de Triomphe for Go Racing and Adrew Carston emphatically won the NZB Canterbury Belle Stakes.

COVID Alert Level2 regulations were amended in September allowing groups of 100 to attend events so the Phar Lap and Balmerino Rooms housed those with the Nightmarch Room again hosting stakeholders for the early October date.

Cambridge trainer Tony Pike dominated proceedings with five wins. THERE YOU GO, and CHANEL won the first two maiden races. STIMULANT won the Two-year-old and FIELD OF GOLD was too strong in the Inglewood Stud Guineas Trial. PROVIDENCEPROVIDES was the final winner all of which were ridden by Kozzi Asano.

FIELD OF GOLD was the punters elect in the feature Group 3 race the War Decree Stakes on October 23 but had to settle for second behind the impressive NOVERRE. Ashburton jockey Jason Laking combined with Jamie Richards for a well deserved big race win.

The Terri Rae trained SOUTHERN OCEAN moved into equal second favourite for the Martin Collins New Zealand Cup with an impressive staying win in the Listed Sothys Spring Classic.

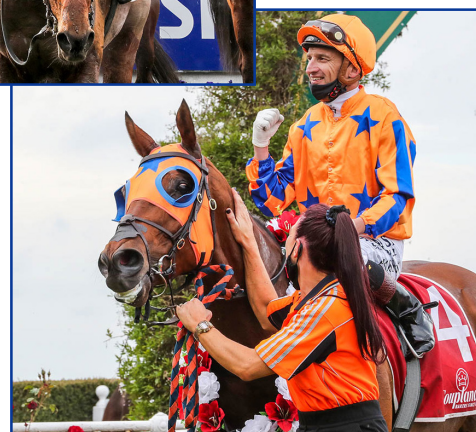
NOVERRE was a sensational winner of the Al Basti Equiworld Dubai NZ 2000 Guineas® clinically disposing of the field after storming home from the rear. In Doing so he gave David Ellis his seventh win in the race, jockey Opie Bosson his eighth and trainer Jamie Richards his third (first in his own name). MERITABLE finished second, ahead of FIELD OF GOLD and MANA NUI.

MR INTELLIGENCE gave Tapanui owner trainers Nikki and Barrie Blatch a day to remember winning the Nautical Boat Insurance Metropolitan Trophy.

Up and coming sprint star BABYLON BERLIN travelled on the plane to trounce the field in the Donaldson Brown Pegasus Stakes for Cambridge trainer Ben Foote and Wanganui rider Lisa Allpress.

MARCUA AURELIUS in the masterful hands of Opie Bosson took out the 17th running of the Coupland's Bakeries Mile. Locally trained SERIOUSLY gave her trainer Meg Cunneen the biggest thrill of her fledgling career finishing second at long-odds.

The very next race ZULUMINOUS triumphed under Danielle Johnson whilst earlier in the day the Group 3 feature sprint the Lindauer Stewards Stakes also went to Te Akau Racing when rejuvenated sprinter SUMMER MONSOON, also ridden by Bosson beat LIVE DRAMA and SATU LAGI.



RACING HIGHLIGHTS

NZ Cup Day 2021 was a surreal affair with less than 1500 people attending. A far cry from the sell-out crowd of 15,000 the year before. Whilst this detracted from the oncourse experience the quality of racing over all three days made for a tremendous spectacle through Trackside TV. Rain on the day stopped at race 4 but not after the going being downgraded to Slow7.

Cup Day, as was the case on the first two days, belonged to Te Akau Racing trainer Jamie Richards. He recorded his 50th Group 1 as a racehorse conditioner in the Barneswood Farm NZ 1000 Guineas® and for good measure trained the first four home. THE PERFECT PINK in the hands of stable jockey Opie Bosson won the Classic ahead of SHEPHERD'S DELIGHT (Samantha Wynne), BELLE EN ROUGE (Michael McNab) and favourite IMERATRIZ (Danielle Johnson). Amongst the part owners are legendary Southland Breeders the Dennis Brothers who bred the filly from a mating of SAVABEEL and their good mare THE SOLITAIRE, a Group 3 winner on the course in 2013.

The 158th running of the Martin Collins sponsored New Zealand Cup® provided the latest in a long line of notable achievements on the Riccarton Park course for Wanganui trainer Kevin Myers. MONDORANI finished too strongly for the favourite BEAUDZ WELL to win the metric two miler. Jamie Richards LEADERBOARD ran third with LINCOLN KING fourth. Sarah MacNab continued her great season in the saddle as winning rider.

The days other Listed feature the Riccarton Park Function Centre Welcome Stakes drew a small field with locally trained filly GRACE'S SECRET winning for Anna Furlong and Shane Kennedy.

The popular Christmas at The Races twilight races completed racing for the calendar year in December.

Classy rider Tina Comignaghi stole the show on the first day of the Riccarton Park Summer Racing Season riding five winners. She won the first four races on the eight race card – IDLE LADY for the Champion/Murphy partnership, MIANNA for Lance Robinson, REPUTABELLE and POSTCODE ENVY for the Pitman partnership – and the 7th race aboard POLAR NIGHT for John and Karen Parsons.

The Stephen Marsh satellite stable provided local breeder Kay Hood with a day to remember on January 29 when MONZA CIRCUITO scored the biggest win of her career in the days feature, the Speight's Timaru Stakes. A prior Group 3 placegetter and multiple stakes placegetter the seven-year-old mare became a Listed winner.

The days feature staying race was run for a stake of \$60,000 thanks to the efforts of the Marlborough Racing Club and their sponsors KAM Transport who with NZTR contributed over and above the base funding of \$40,000. MR INTELLIGENCE ran out a decisive winner.

The annual Banks Peninsula Racing Club fixture was run at Riccarton Park under atrocious conditions for summer racing. Significant rain in the lead up produced a Slow8 track that deteriorated to Heavy10 as rain continued throughout the day.

The days feature the C S Stevens Memorial Banks Peninsula Cup went the way of ORIGINAL GANGSTER.

The Riccarton Park Summer Racing Season ended with the fourth day, an Industry meeting, on Friday 25 February. Visiting Matamata apprentice Joe Kamaruddin stole the show with three winning rides.

Some interesting results came out of the eight race March Industry Meeting. The most notable was the all the way win by SUMMER FESTIVAL over 2000 metres in the hands of Courtney Barnes. The win was the seven-year-old's first in New Zealand at his eleventh start in this country and second from Stephen Marsh's Riccarton Park stable. Bred in Great Britain SUMMER FESTIVAL started his career in Italy where he won six from nine starts including the Italian Derby a Group 2 event. He then went to Hong Kong in 2019 where he was winless in 21 starts before coming to New Zealand.



RACING HIGHLIGHTS

The First day of the Riccarton Park Autumn Season started in the best possible conditions for Autumn racing. Perfect weather and an ideal Dead track.

The days feature Group 3 race, the Valachi Downs South Island Breeders Stakes went to IRISH GIRL prevailing in a good field of fillies and mares. She was ridden by Terry Moseley.

Seaton Family Hororata Gold Cup also went the way of Moseley aboard the John and Karen Parsons trained EL GLADIADOR

Ruakaka mare IRISH GIRL made it back-to-back Riccarton Park features in the Avon City Ford Easter Cup. Terry Moseley again partnered the Ken Rae and Krystal Williams-Tuhoro trained five-year-old

REPUTABELLE cemented her place as the souths leading three-year-old filly with a decisive win in the NZB Insurance Stakes. She beat Marton visitor UNUSUAL COUNTESS and Cambridge trained DIVINE SAVA. Tina Comignaghi rode the Matthew and Michael Pitman trained filly.

The time-honoured Coca-Cola sponsored Canterbury Gold Cup was fittingly won by the highest rated runner. PRISE DE FER a proven Group 1 performer and a Group 2 winner prevailed for Mark Walker. Ashburton jockey Jason Laking continued a rewarding season with Te Akau Racing as the winning rider.

Most racing fans considered that REPUTABELLE would continue her winning ways in the New Zealand Bloodstock Warstep Stakes, but it was not to be. The winner of NZ Bloodstock Southern Filly of the year had to settle for third behind BURGIE and BELLE OF THE BALL. Brian and Lorraine Anderton bred the filly and race her in partnership with BJs Southern Syndicate.

Positive comments flowed after the inaugural raceday on the Riccarton Park Polytrack. 7 races were run with horses winning from many differing positions in the running.

One of the greatest supporters of the project has been local trainer Ross Becket who put his money where his mouth is by sponsoring the days feature. Joining him in sponsoring the race was mine host at Coasters Tavern, Ross Murdoch. A fitting result unfolded with SHE'S RECOMMENDED running the field ragged under stable employee BB Hong.

The honour of winning the very first Polytrack race goes to EULOGY SHOW, part owned by racing stalwart Calvin Fisher. Trained at Balcairn by Centaine Spittles and ridden by Krishna Mudhoo, EULOGY SHOW won the 2200metres Maiden by 10½ lengths.

As was the norm over the four days of the Riccarton Park Autumn Racing Season racing on the last day, 7 May, was conducted under perfect weather conditions and on ideal track conditions.

Lance Robinson presented the two highest rated runners in the days feature the Daphne Bannan Memorial Great Easter Stakes. The mare LIVE DRAMA beat her male stablemate KHIMAR WAR to give the Riccarton Park trainer the quinella. Kavish Chowdhoo rode the winner.

The Berkley Stud Champagne Stakes was the other Listed race on the programme. DISS IS DRAMATIC improved on a second the previous meeting to claim honours.

The second Polytrack raceday took place after heavy rain earlier in the week and rain again on race morning. If the meeting had been on the turf, it would have been held on a heavy track.

Ninety-nine runners raced in 9 races at an average field size of 11.

Three new track records were set



RACING HIGHLIGHTS

Matamata visitor VIRTUOSO LAD lowered his own mark for the 1200 meters winning the Steriline Racing Rating 74 in 1-09.22.

The days other Rating 74 race was The Speights over 2200 metres in which the Andrew Carston Trained VULTURE STREET ran 2-15.33 under Kylie Williams to set a new mark

An Industry Meeting (16 June) provided some interesting and memorable racing on the Polytrack

GREEN LUCK headed the field in the Riccarton Park Function Centre Open Handicap with 62kg on the back of a career in Australia and Hong Kong which netted 8 wins from 41 starts and NZ\$1.1 million in prizemoney. The seven-year-old rallied to set a new track record of 1-21.69.

In very pleasant weather, The Mid Winter Christmas raceday (25 June) was run on a Heavy9 track.

Rohan Mudhoo had combined with his employer, Mike McCann's FRANKIE THE FOX at the Grand National Festival of 2018 to ride his first ever winner at FRANKIE's first start. Four years and 41 starts later the trio again came together to win the Greenwood Amberley Cup to record FRANKIE's sixth career win all with Rohan aboard. Longshots were the order of the 5th Polytrack raceday with not one favourite winning.

SOMBRA DEAMOR set a new track record of 1-34.33 for 1600 metres when racing past hot favourite CHOISIA PRINCE.

The highlight of Polytrack racing on 15 July was the win by STRIKE FORCE in the Speight's Open Handicap. STRIKE FORCE had won two races from two starts when trained by Danny Crozier, was then sold to Hong Kong, did not race, and returned to New Zealand. Ryan Thistoll, who works on the Riccarton Park Grounds Staff purchased the now six-year-old gelding off Gavelhouse and trained him to win at his first start.

The 31st and last Riccarton Park Meeting for 2021/22 took place Friday 29 July on the Polytrack.

The last say of the Riccarton Park racing season went to the Les and Richard Didham trained FIRST ROCK. Under apprentice Megan Taylor FIRST ROCK ran the sprinters ragged setting a new track record of 1-08.99 for the 1200 metres.

The days other Rating 74 race went the way of DA VINCI GIRL who is becoming something of a Polytrack specialist for the Matthew and Michael Pitman training partnership.

1. Basis of Preparation

Reporting entity

The Canterbury Jockey Club (Inc.) (henceforth, "the Club") is incorporated under the Incorporated Societies Act 1908. The primary objective of the Club is to promote, conduct and control thoroughbred racing and is registered with the New Zealand Thoroughbred Racing Code ("the Code") consistent with the Code's constitution. The Club is a recognised industry organisation in accordance with the Racing Act 2020.

The financial statements presented are for the Club for the year ended 31 July 2022 and were authorised for issue by the Chairman on 21 September 2022.

Statement of compliance

The financial statements have been prepared in accordance with the Racing Act 2020, which requires compliance with generally accepted accounting practice in New Zealand ("NZ GAAP").

As the primary objective of the Club is not towards making financial returns but the promotion, conduct and control of thoroughbred racing, it has designated itself as a not-for-profit public benefit entity (PBE) for financial reporting purposes.

The Club has elected to report in accordance with the Public Benefit Standards Reduced Disclosure Regime (PBE Standards RDR) on the basis that it is not publicly accountable and not considered large for financial reporting purposes.

The Club qualifies as a Tier 2 reporting entity as for the two most recent reporting periods it is not publicly accountable and not large (operating expenditure has been between \$2m and \$30m in the current and prior period).

Measurement basis

The financial statements have been prepared on a historical cost basis, and are presented in New Zealand dollars rounded to the nearest dollar which is also the Club's functional currency.

Going concern

The financial statements have been prepared on a going concern basis.

Changes in accounting policies

There have been no changes in accounting policies.

Significant accounting judgements, estimates and assumptions

The preparation of the Club's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures. Uncertainty about these assumptions and estimates could result in outcomes that may require a material adjustment to the carrying amount of assets or liabilities affected in future periods. The judgements, estimates and assumptions are evaluated on a regular and continuing basis, including expectations of future events, to a reasonable extent to assess their implication on reported revenues, expenses, assets, liabilities and disclosures in the financial statements.

Useful lives and depreciation methods and rate for Property, Plant and Equipment are detailed at note 11.

Income taxes

The Club is exempt from New Zealand income tax pursuant to section CW 47(2) of the Income Tax Act 2007.

Goods and Services Tax

All amounts are stated exclusive of goods and service tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

2. Revenues and direct costs & expenses

Revenue is recognised to the extent that it is probable that the economic benefits or service potential will flow to the Club and it can be reliably measured, regardless of when the payment is being made. Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duty.

Revenues are classified as to whether they arise from an exchange or non-exchange transactions. An exchange transaction is one in which the Club receives assets or services, or has liabilities extinguished, and directly gives approximately equal value to another entity in exchange and includes sale of goods, rendering of services and charges for the use of the Club's assets (e.g., interest and dividends). The Club recognises revenue from exchange transactions when the revenue recognition criteria mentioned above are satisfied.

A non-exchange transaction is any other transaction not classified as exchange.

2.1 Race meeting revenue and expenses

Race meeting revenues comprise the amounts received or receivable for services provided and goods sold that directly relate to race meeting events conducted by the Club during the financial year. These primarily include industry distributions from TAB New Zealand and the Code and other receipts that directly relate to the Club's race meeting activities from members of the Club (aside from membership fees included in other operating income) and third parties in the form of grants and subsidies.

The Club incurred certain direct costs and expenses in conducting its race meeting days and recognises these as costs and expenses when incurred regardless of when the payment is made unless they qualify for recognition as asset. Direct costs and expenses on race meeting days are presented below excluding depreciation expenses which are included as part of other operating expenses in note 3.

The Board has resolved to identify the net insurance proceeds from the demolition of the Members Grandstand in a Special Projects Reserve to meet the costs of any earthquake strengthening that might be required to other buildings, the re-establishment of the Members Grandstand Site and future development of the property.

Amalgamated Clubs' contribution - \$1,449,340

The net assets of the respective Clubs have been contributed to the Canterbury Jockey Club (Inc.) as loans on demand and are interest free.

As the chance or practicalities of these loans ever being called is remote, in accordance with accounting standards, they have been reclassified within equity to a special reserve.
