 A purchase shall be deemed to be made when the offer is accepted or a deal successfully negotiated and the mare cleared by Stud. The purchase price is exclusive of GST and GST shall be payable on successful purchases. I agree that should I be successful in making a purchase, I will be required to pay a 10% usage deposit of the purchase price plus GST to Canterbury Jockey Club. 									
4. I agree to pay the balance of purchase price plus GST to Canterbury Jockey Club within fourteen (14) days of obtaining a 42 day Positive Pregnancy Test. In the event of a mare being walked into a stud or leaves the stud before the 42 day test, as Owner I shall have that mare Pregnancy Tested at 42 days and the results forwarded to the Club, the Club shall take it that the mare is in foal unless certified otherwise.									
6. I understand the	I understand that the service is for the 2023 Season only and that a LIVE FOAL GUARANTEE will be given on the mares certified in foal.								
3. Live Foal Guarantee: a) This L.F.G will only apply if all charges are paid as at 31st March 2024; b) Should a Live Foal as described in Clause 7 not eventuate, the Club reserves the right to give a refund of the money paid per Clause 4, provided the mare is foaled at a Stud or an approved agistment property; c) The right to LFG is lost if the mare is sold or exported; d) The right to a LFG is lost if the mare has not been vaccinated against Equine Herpes Virus. A Veterinary Certificate of Vaccination will be required to secure the LFG should the need arise.
