Dianne Logie, Chair, Canterbury Jockey Club

I am proud to present to you the members of the Canterbury Jockey Club my first annual report as chair of this historic organisation. I am proud also to do so as the first woman Chair in the close to 170 years history of the Club.

On a positive note, the season operated without any restrictions imposed by Covid19 protocols and regulations. This enabled us to fully promote our racing and functions businesses.

Regrettably I must open my report by acknowledging the abandonment of racing part way through New Zealand Cup Day. Following the running of race three one of the runners, HARMONIOUS, slipped at about the 400 metres mark eight metres out from the rail. Following the race riders in conjunction with the Racing Integrity Board Stipendiary Stewards deemed the track unsuitable for racing and racing for the day was abandoned. Remedial works were undertaken by the Club's grounds staff on Saturday and Sunday with the balance of the programme comprising nine races including the two feature the Martin Collins New Zealand Cup® and Barneswood Farm NZ 1000 Guineas® being held on Monday 14 November 2022.

New Zealand Thoroughbred Racing conducted an inquiry into how this occurred with which the Club co-operated fully. The outcome of which has resulted in not only Riccarton Park but all racecourses having a period set aside in which annual track renovations will be undertaken to minimise the chances of a similar occurrence in the future.

This was a most costly exercise for the Club which the Treasurer and Chief Executive will detail in their reports.

What I do wish to do is to sincerely thank all the members and sponsors for their support of the Club during this particularly trying and stressful time. Almost every member and sponsor refused to accept offered discounts and re-imbursements with some even offering to increase their commitment. This support of their Club shows how much the CJC and NZ Cup Meeting means to Canterbury.

The Club received consent to demolish the Grand National (Public) Stand on Wednesday 9 November 2022. A thorough tender process was undertaken with the contract to demolish being awarded to Southern Demolition & Salvage. Works commenced in late January 2023 with the removal of asbestos and continued through the remainder of the season with completion anticipated in September 2023 in time for a re-invention of use of the site for the New Zealand Cup Meeting. The Chief Executive will elaborate on this in his report.

The Board is investigating concepts for a permanent use of the site but budget and building costs will have a significant bearing on what evolves.

In a year of intriguing matters in April the Board received a delegation of NZTR Chair, Chief Executive and Chief Operating Officer who proposed a shift of the Al Basti Equiworld Dubai New Zealand Two Thousand Guineas® and Barneswood Farm New Zealand One Thousand Guineas® to the northern region. The Board of your Club resisted the arguments for such a move and responded formally to the Board of NZTR who accepted the races remain at Riccarton Park.

On a hugely positive note, the season ended with the news that TAB NZ had entered into a partnership agreement with international company Entain with guaranteed payments to the industry for the next five years. This has resulted in an increased Club funding from 2023/24 and most importantly significant stake increases. The Chief Executive will detail how these relate to your Club.

## CHAIR REPORT cont.

My predecessor Gordon Fulton reported on the Sapere Report and its recommendation for the future of Rangiora Racecourse. At the time of writing his report he stated that "NZTR does not have racing at Rangiora in its venue plan and HRNZ is to determine its position on what it sees as the future for Rangiora Racecourse". At time of writing this report we continue to await a decision from Harness Racing New Zealand as to how it views Rangiora Racecourse in its venue plan. Once that is known this Club can determine how it approaches the future of Rangiora Racecourse.

The Club had two notable staffing changes during the year. Eric Cormack, retired on 28 July 2023, after 25 years with the Club as Manager of the Riccarton Park Function Centre and Operations Manager. Gareth Murfitt, after 6 years, left the Club to expand his career options at the end of May 2023. Both men made amazing contributions to the Canterbury Jockey Club, they leave as friends of the Club, and we wish them all the very best. Phil Leabourn was promoted from within to take Eric's role as Operations Manager with Lauren Anderson joining as Hospitality Manager whilst the Club continues to seek a replacement Business Services Manager.

I wish to thank these people and all the staff of the Club for their efforts in another extraordinary year in the history of the CJC.

The Club now conducts 31 racedays with the introduction of Polytrack racing two seasons go. Given the increase in midweek meetings the Board has implemented a midweek strategy of operating these days with only the Nightmarch and Phar Lap Rooms open. This has created efficiencies and cost savings through economy of scale. The Board looks forward to spending a day's racing with Members on these days.

On behalf of the Board, I extend its appreciation to the four Ward Committees who so ably run their racemeetings, that is Amberley, Hororata, North Canterbury and Riccarton Turf.

I wish to personally thank all my fellow Board Members who have so devotedly worked on members behalf to manage the affairs of this great club.

I also thank the Trustees of the Christchurch Racecourse under Chair Peter Cordner and acknowledge with sympathy the passing during the year of Trustee Nigel Babbage. I also thank them for the honour of being appointed a Trustee to replace Nigel.

Jeffrey McCall, Treasurer, Canterbury Jockey Club

It is my pleasure to be able to provide this Treasurer's Report highlighting the major outcomes in the 2022/23 year.

### New Zealand Cup Day

1. Our budgeted profit was \$270,000.
2. The New Zealand Cup Meeting and the abandonment and rescheduling of part of New Zealand Cup Day itself led to an approximate loss of \$750,000 against the projected returns. The first Saturday and Wednesday we had been ahead of budget. Unfortunately, the postponement of the busiest day of the year had significant impact upon the financial position of the Club at the end of the year.
3. Of that \$750,000 loss, the major contributors to that were:
  - 3.1. The reimbursement of admission tickets and privileges to attendees of approximately \$380,000.
  - 3.2. Penalties imposed by NZTR, by not paying full funding for the operation of New Zealand Cup Day and the loss of income from oncourse wagering. The on-course funding received was \$333,503 against a budget of \$410,990.
  - 3.3. The race day gross profit had been budgeted to be \$634,380 where actual was \$424,924. The difference between budget and actual of approximately \$210,000 was due to the abandonment of New Zealand Cup Day.
  - 3.4. There was also the issue of reputational loss, which as a general statement, this was potentially most felt within those loyal attendees and Club Members of the industry. The general members of the public and those attendees who may only attend once or twice a year, the reimbursement of the admission ticket and/or privileges they may have purchased alleviated any potential reputational loss.
4. Therefore, instead of a projected operational surplus of \$270,000, the Club suffered an operational loss of \$560,846.

### Riccarton Park Function Centre Operation

5. The overall RPFC operation had a profit of \$253,108 against a budgeted operating profit of \$360,599.
6. This in part was due to New Zealand Cup Day not proceeding on the Saturday. However, this was also a direct result of having to close rooms for approximately four months during the demolition of the Grand National Stand. Considering these factors the surplus of \$253,108 was pleasing.

### Unbudgeted Expenses

7. There were several unbudgeted expenses during the past year, in particular:
  - 7.1. In the permanent stabling area, during periods of heavy rainfall, a number of sumps had to be replaced, which were seen as a repair and maintenance cost. The average cost of repair and maintenance of the sump holes per stable was between \$40,000 and \$50,000.
  - 7.2. As a result of the demolition of the Grand National Stand there was costs for mapping and replacement of the underground systems, including plumbing and the cost of repairing old underground pipes and replumbing.
  - 7.3. There were additional professional consultancy fees incurred during the year, which had not been anticipated, particularly concerning the abandonment of New Zealand Cup Day on the Saturday.

### Demolition of Grand National Stand

8. The major works during the year was the demolition of the Grand National Stand.
9. The initial cost of demolition and the construction of a replacement building was approximately \$9,000,000. The insurance payout we had received for the demolition and replacement of the building was \$6,000,000.
10. Based on the initial indicative costs, we proceeded with the engagement of architects and other professional



consultants to design a replacement building for the site. We asked for an updated cost once we had reached an agreement in principle as to the concept of the replacement building. The estimated cost was \$14,000,000.

However, at the time this cost was provided, this estimated cost applied only to the conceptual new building. Demolition costs were additional. Given the magnitude of this amount the Board had to make the decision not to proceed.

11. The Board is currently considering alternative structures that could be constructed on the site Grand National Stand.
12. The outcome of that decision will impact on the long-term future of other buildings in particular the Show Gate and whether funds should be expended to upgrade that.

### Net Profit/Loss

13. The net profit is shown as reflecting a loss of \$3,191,280 against last year's profit of \$3,068,167.
14. The result includes \$1,236,533 of earthquake repairs and betterment. Although this looks concerning, the position must be seen in the context of the net insurance payout that we have received, of approximately \$5,250,000 which had shown as income in the 2019/20 season resulting in a profit to the Club in the year \$4.4 million.
15. There was a delay of approximately 3½ years between the receipt of the insurance payout and the demolition of the Grand National Stand.
16. This was due primarily to the contested consent application for the demolition of the Grand National Stand, which lead to a full hearing before eventually being granted.
17. Until that Consent was obtained, we did not know even if we were able to demolish the building.
18. After obtaining consent, the expenditure incurred in the demolition of the Grand National Stand happened to fall within the last financial year. Therefore, although we have a loss recorded of \$3,191,280, it must be remembered that against the expenditure incurred leading to that loss, was the insurance money received in 2019/20. In effect, the expenditure was funded by the insurance payout.
19. The other factor was \$1,393,430 of depreciation.

### Race Meetings

20. For the 2023/24 racing season 31 race meetings have been scheduled for Riccarton Park. That is approximately 10% of all races held in New Zealand. The Club hosts more race meetings than any other club.
21. An outcome of having the Polytrack and resulting 31 race meetings a year at Riccarton Park is that trainers have the ability now to maintain a higher number of horses in training during the winter months.
22. We have now reached a position where each race meeting has a positive return to the Club.
23. I wish to acknowledge Gareth Murfitt's resignation during the year as our Business Services Manager. I thank him for his efforts on behalf of the Club, during his time at the Canterbury Jockey Club.

Tim Mills, Chief Executive, Canterbury Jockey Club

With the impact of Covid19 behind us the 2022/23 season was one of great anticipation that normality would resume.

Unfortunately, that was not to be the case when the most damaging of blows happened on New Zealand Cup Day. A runner slipping in the third race set a chain of events that resulting in racing being abandoned and the remaining nine races taking place on Monday 14 November.

The Treasurer details the significant financial impact of this occurrence in his report.

Understandable New Zealand Thoroughbred Racing undertook investigations into how this occurred with the findings being released publicly. The Club has accepted the findings and taking steps to minimise such a thing happening again. An aggressive annual renovation is to be undertaken each year in an eight-week window from mid-November to mid-January. This will involve removing the turf, doing aeration and de-compaction work to the soil profile, and re-sowing the track. This was done post Cup Meeting 2022 with very positive results. It is no consolation that similar abandonments happened at other tracks at about the same time but what that highlighted to the industry at large is the need for every racecourse to undergo an annual renovation and this is now something that is being built into the dates structure of each racecourse. That is a small silver lining from a very black cloud. To accommodate the eight-week window the popular December 'Christmas at the Races' meeting will be held on the Polytrack.

There was not a member of staff who was not devastated by what happened on New Zealand Cup Day and I can only humbly thank them all for the way they pulled themselves up, rolled up their sleeves and did what they had to do to firstly get the balance of the programme run two days later and then deal with the aftermath. As members you can be proud of the people working for your Club.

I would also make special mention of the Club's sponsors and supporters who, almost to a man, in typical New Zealand steadfast manner stood by their Club in a tough time.

The Polytrack continues to be a very effective tool in the Riccarton Park training tracks tool-bag. The final component of the project the installation of the lighting will take place in November this year to be ready for use in the winter of 2023. This decision was made in conjunction with NZTR and industry participants after nine poles were positioned to determine any impact of shadows.

Riccarton Park has a very strong trainer base, and the Club will have to plan for an inevitable extension of training stables as the benefits of the training tool bag – grass training track, Polytrack, plough, sand, and swimming pool – continue to evolve.

In an exciting year for Riccarton Park trainers the South Island trainer's premiership went down to the wire with Andrew Carston pipping the Matthew and Michael Pitman partnership in a see-sawing battle on the last Polytrack meeting of the season to take the title 42 wins to 40.

The Grand National Stand was demolished in 2023 with the site being re-established for, in the immediate term, use by temporary facilities. The project was not as simply as demolishing an old building as water, power, sewerage, drainage, fibre, and telecommunications all had to be re-directed. Demolition also highlighted flaws in century old piping with the decision being made to future proof by replacing water and sewerage to the roadside. A very costly exercise but an essential one that will futureproof the racecourse. The site will provide for exciting and innovative options for both raceday and non-raceday set-up particularly at the NZ Cup Meeting.

The decision by TAB NZ to enter into a partnership agreement with Entain with a guaranteed payment to the racing industry over the next five years has some tremendous benefits for racing at Riccarton Park with increased Club funding and stake money.

Stake money highlights include:

1. Al Basti Equiworld Dubai New Zealand Two Thousand Guineas® from \$550,000 to \$600,000.
2. Barneswood Farm New Zealand One Thousand Guineas® from \$400,000 to \$500,000.
3. Lindauer Stewards Stakes from \$120,000 to \$140,000.
4. Windsor Park Stud Canterbury Breeders Stakes from \$100,000 to \$120,000.
5. 11 races on 1st & 2nd days of the NZ Cup Meeting increase from \$50,000 to \$65,000.
6. 6 races on NZ Cup Day increased from \$60,000 to \$65,000.
  - Total increase at the NZ Cup Meeting of \$405,000.
7. Ten Listed and Group 3 Races have a \$15,000 increase in stake.
8. 13 Feature meetings (Other than NZ Cup Meeting and GNF) increase by a total of \$816,500. \$40,000 minimums and \$50,000 minimums for open handicaps.
9. 12 Industry meetings increase by a total of \$331,000.
  - Total increase at racemeetings other than NZ Cup Meeting approximately \$1,422,500.
10. A new race, the Southern Alps Challenge, carded for the autumn. Carrying a stake of \$350,000 this race is for South Island trained horses only.
  - TOTAL STAKE INCREASES FOR 2023/24 OF CIRCA \$2,177,500.

I wish to sincerely thank all Staff, Board, Committee members, and Stakeholders for their efforts to not only the Canterbury Jockey Club but racing in Canterbury and New Zealand.

I cannot conclude without acknowledging the contribution of Eric Cormack who retired at the end of July from his role as Operations Manager and Gareth Murfitt who took a new career path in May. Two better workmates one could not have wished for.

## RACING HIGHLIGHTS

- The Winning Edge Presentations Winter Cup had not been won by a Canterbury galloper since McLASKRY in 1999. Ashburton Owner Trainer Bevan Wilson, a past All Blacks fullback, and Christchurch rider Terry Moseley ended that run of outs in emphatic fashion with LORD DARCI in the 2022 renewal First day of the Grand National Festival was conducted on a Heavy10 track.

- Sharing in the owning and training is Bevan's wife Robyn, daughter of legendary Gore trainer Rex Cochrane.

- The Koral Steeplechase drew a disappointingly small field of only four runners but despite that a little bit of history was extended with Awapuni trainer Mark Oulaghan recording his seventh win in the race. WEST COAST ridden by top jockey Shaun Fannin beat a Kervin Myers trained trio for a family ownership group headed by Ron Williamson. Ron the backbone of the Kurow Jockey Club has long been a stalwart of racing in the south.



- Kevin Myers dominated the Days feature Hospitality NZ Canterbury 132nd Grand National Hurdles on the 2nd day in every aspect. He lined up five of the seven runners, prepared the quinella and went into the record books as the winningest trainer in history with HAPPY STAR giving him his fifth win in the race. Champion jumps jockey of 2012/21 Shaun Phelan took the mount.

- The Grand National Hurdles was the only race run on the turf with the eight flat races being run, for the first time, on the Polytrack.

- The loudest cheer on the day was reserved for the Grand National Amateur Championship sponsored by Nautical Insurance. The race for the Amateur riders proved to be a thrilling contest. Lisa Kennedy took the honours aboard EKSTREMEMISS.



- The 3rd day on 13 August and it will be long time before there is a more popular winning owner in the Birdcage than Ron Williamson. The joy and affection for Ron was evident after WEST COAST led a procession throughout the 5600 metres of the Racecourse Hotel & Motor Lodge Grand National Steeplechase to give trainer Mark Oulaghan a record extending seventh win in the famous race. Topflight jumps jockey Shaun Fannin got an overdue win in the race.

The 9th Polytrack day highlight was undoubtedly the debut of MISS TAKE who blitzed the 1200

metres maiden for three-year-olds by 9½ lengths. Her ability was well known as she paid a microscopic \$1.20 for the win and a ¼ share had transferred ownership the day before to prominent Australian owner Manoj Wanzare. Top rider Lisa Allpress steered the filly for Riccarton Park trainer Terri Rae.



- A seven-race card took place at the penultimate meeting of the Riccarton Park Polytrack Season on Thursday 1 September.

- Punters got it right with favourites winning five of the races on offer.

- The first day of the Riccarton Park Spring Season on 3 September took place in almost ideal conditions.

- Te Akau Racing prepared two winners with BURGUNDY ROSE and DANCARINA.

- The 11th and final Polytrack meeting for 2022 was run on Wednesday 14 September.

- The seven-race card was dominated by two Mark Walker trained mares who scored impressive wins for stable apprentice Joe Kamaruddin.

- The 2nd Spring Raceday feature was the New Zealand Bloodstock Canterbury Belle Stakes with most punters expecting the locally trained MISS TAKE to score a hometown victory. Te Akau three-year-old ONE KISS was 2nd favourite the night before paying in the mid-\$4 range. Whilst scoring a dominate win the divided declared, which was in excess of

\$11, had many racing fans scratching their heads. The filly was ridden by champion jockey Opie Bosson.

- On the 3rd Spring Raceday, popular trainer Jackie Burrows blew the punters away in the Waimakariri Businesses North Canterbury Cup. At \$55.40 punters were lamenting "Are you serious?" when ARE YOU CEREAL defeated the favourite, Mark Walker trained, CAMPIONESSA



- On 22 October the days feature the Group3 War Decree Stakes, the quinella was the same as it had been three weeks earlier in the Inglewood Stud Guineas Trial but this time placings were reversed. The filly DISS IS DRAMATIC beat the colt COGNITO over the 1600 metres with MALBOROUGH BAY again finishing third.

- Two races later in the Sothys Spring Classic over 2000 metres. Kavish Chowdhury steered ELIZABETH ROSE home to a most popular win. The Anna Furlong and Shane Kennedy trained five-year-old mare is raced by Club Life Member Kevin Hickman together with several his closest friends, CAMPIONESSA ran second ahead of JACK KNOWS BEST.

- The 1st Day of the New Zealand Cup Meeting was a real family affair in the Al Basti Equiworld Dubai NZ 2000 Guineas. PIER part owned and bred by Darryn and Lou Weatherley and trained by Darryn in partnership with daughter Briar provided Darryn with the Group 1 win that eluded him as a jockey. Michael McNab rode the winner of the 50th edition of the 1600 metres Classic. DESERT LIGHTNING tried valiantly to give the Barneswood Farm ownership team a Group 1 win finishing second with the filly PROWESS third.

- Australian jockey Josh Parr gained a Listed win in the colours of Te Akau Racing winning the the Nautical Boat Insurance Metropolitan Trophy, aboard CAMPIONESSA.
- Awapuni trainer Lisa Latta inevitably gets a good result when travelling horses to Riccarton Park. LINCOLN'S KRUIZ provided that in the Donaldson Brown Pegasus Stakes, beating the locally trained ROCKLAND and the southerner BOUYANT.

- HE'S A DOOZY landed some big bets when winning the 2nd days feature, the Coupland's Bakeries Mile. Ridden by Kozzi Asano, the five-year-old South Island bred is yet another stakes winner prepared by Awapuni's Lisa Latta.



- Two races earlier Latta had struck again with BELCLARE who won the Valachi Downs Canterbury Breeders Stakes in the hands of Michael McNab. AVAQUINELLA and FASHION SHOOT filled the minor placings.

- Mark Walker provided the trifecta in the Riccarton Park Function Centre Welcome Stakes for the Two-year-olds. SKY ON FIRE, the favourite and ridden by visiting Australian rider Josh Parr beat RUBICON CROSSING and RHETORICAL.

- What promised to be a New Zealand Cup Day out of the box with a sell-out crowd evolved to a calamity when racing came to an end when HARMONIOUS slipped during the running of race • After remedial work undertaken on Saturday and Sunday, the remaining nine races were run as a new raceday on Monday 14 November.

- Visiting Victorian jockey and expat Cantabrian Dan Stackhouse rode the winners of all three races conducted on the Saturday aboard UGO, OSO SAVVY and STAR BALLOT.
- Back on the Monday, a budding superstar LEGARTO gave owners and backers some anxious moments when proving difficult to load and breaking a bridle before the Barneswood Farm 50th NZ 1000Guineas.

In the end the \$1.30 favourite treated racegoers to a stunning performance running away to win by 4 ¾ lengths in the hands of Ryan Elliot. BEST SELLER ran second ahead of the Kevin Hickman owned BLUE SOLITARE.

- Wanganui trainer Kevin Myers made it back-to-back Martin Collins New Zealand Cups and his third overall with the \$2.80 favourite ALJAY. Tina Comignaghi rode the winner to give her three winners on the day.



- Trained at Ascot Park by Sabin Kirkland, BUOYANT improved on his first day third placing to win of the Lindauer Stewards Stakes. although trained in the deep south, this was BUOYANTS fourth win at Riccarton Park.



- The Christmas at the Races meeting on 2 December was held on the Polytrack so to enable planned renovation on the Course proper to be brought forward.
- The meeting was extremely popular with Christmas party goers and all reserved events were sold out.
- Nine-year-old BLUEY'S CHANCE a past placegetter in a Wellington Cup dropped back in class and rallied late to win the Neovia Advisors & Accountants Rating 65. Kenny Moore's pride and joy was recording his sixth win.
- The 19 January meeting was shifted to Ashburton so the meeting on Saturday 28 January was the first of 2023.
- Northern rider Jasmine Fawcett stole the show riding five winners including bringing up her 200th career victory.

- The Speight's Timaru Stakes was won by dual code trainer Mark Jones with PHELAN THE POWER who to scored by a narrow margin for Jasmine Fawcett.



- Unfortunately, 40mm of rain in the leadup saw the fourth day of the Summer Racing season (24 February) be conducted in Heavy10 conditions.

- In the ODT Southern Mile Qualifier, the Leonard Stewart trained ZADANE ran out an impressive 5 lengths winner for Gos Jogoo.

KIKIMORA became the third winner of nine lots from the 2021 Windsor Park Stud "Rugby, Racing & Beer luncheon & yearling auction when winning on 9 March. Purchased for \$11,000 the now three-year-old is trained by Anna Furlong & Shane Kennedy

- After being handicapped at 60kg, 58kg and 57kg at her previous three starts LIVE DRAMA promised to be very hard to beat with 55.5kg under the set weight and penalties conditions of the Valachi Downs South Island Thoroughbred Breeders Stakes on 25 March. Punters thought too and as favourite she justified the support. Lance Robinson was delighted and stablemate AVAQUINELLA put icing on the cake running third. Kavish Chowdhury was the winning rider. BURGIE split the Robinson pair.

- Unfortunately rain over Easter resulted in a Heavy8 track for the 2nd day of the Autumn Racing season.

- The Avon City Ford Easter Cup saw TIMES TICKING the highest rated runner carrying the steadier of 60kg but that did not prevent him scoring game ½ head win over TYLER EIGHT and OUR ECHO.

- Last start Group 1 placegetter LUELLA CRISTINA was thought by many to be the one to beat in the NZ Airfreight Stakes but could catch MISS LALLA who took her record to two wins and a second from only three starts. Trained locally by Anna Furlong and Shane Kennedy the three-year-old was ridden by Shankar Muniandy.

- A week of rain resulted in very heavy going for the third day of the Autumn Racing Season.

- The day belonged to Southland connections, trainers, Kelvin Tyler and daughter Aimee and, owners, his brother Alan and his wife Marie.
- PRINCE ALBY started the day in style with a comprehensive win over 2500 metres. For good measure stable mate DUNHILL ran second with both owned by Kelvin and his wife Vanessa.
- CLASSIC DIVA won the Rating 75 1600 metres and SHE'S A CON won the New Zealand Bloodstock Warstep Stakes, both in the ownership of Alan and Marie. Kylie Williams was the jockey on both occasions.



- LUELLA CRISTINA won the New Zealand Bloodstock Southern Filly of the Year Series title on 8 points off the back of two second placings.
- The days feature event eluded Team Tyler with LIGHTNING JACK finishing third behind TIMES TICKING and CAPO DELL IMPEREO in the time-honoured Coca-Cola sponsored Canterbury Gold Cup.



- The anniversary of the inaugural Riccarton Park Polytrack raceday was held on Thursday 4 May 2023. Seven races were held with a healthy average field size of 10.9.
- The 4th Autumn Raceday was Riverton to Riccarton Park again for Team Tyler and another feature race win with LIGHTNING JACK storming away with the Daphne Bannan Memorial Great Easter Stakes.



- The Berkley Stud Champagne Stakes was won by Whangarei based Kenny Rae who has long been a very good trainer of two-year-olds. With daughter and training partner Krystal Williams now having a Christchurch based stable he was able to send ILLICIT DREAMS south. Most pundits thought the race would be between favourites PENVOSE LAD and CU CHULAINN but they had to settle for second and third.

- The second day of the 2023 Polytrack season was a Feature meeting.
- Owner Trainer Mike McCann's pride and joy FRANKIE THE FOX won his eighth race, and second on the Polytrack in the Open 1600. Shankar Muniandy rode the seven-year-old.
- The feature event on the Industry date on 2 June was a Rating 75 over 1600 metres. CAITLYN JAY won her second race from six attempts on the Polytrack surface for Andrew Carston and his former apprentice Kozzi Asano.

- Matthew and Michael Pitman went into the 15 June meeting with a one-win lead over Andrew Carston in the South Island trainer's premiership. At days end both stables were locked at 31 wins apiece.

- The last Saturday meeting of the Riccarton Park season (24 June) was run on true winter going with persistent rain.
- Winter Cup hopeful ZELENSKI lumped topweight of 60.5kg, reduced to 58.5kg with Kelsey Hannan's claim, to win the days feature the Greenwood Amberley Cup. Kenny Rae was on course to assist daughter and training partner Krystal Williams saddle the gelding from her Christchurch satellite stable.

- The 5th Polytrack Raceday may have been a defining moment in the South Island Trainers premiership. Andrew Carston prepared three winners, DAME COUNTY, THE ARCTIC BLAST, and PROPER TWELVE. Team Pitman clawed one back with THIRD DECREE but Carston finished the day leading the premiership by 36 to 33. The 6th Polytrack Raceday was a Pitman benefit. The father and son team prepared four of the eight winners on the programme to move ahead of Andrew Carston on the premiership by 39 to 37.

- The last Riccarton Park raceday of 2022/23 was held on the Polytrack (28 July) and provided a major fundraiser as the "Red Nose Day, Races for Cure Kids". They achieved twice their financial goal in a fun filled event.
- Three winners ELANIA, AROWOFDIAMONDS and MUMBO JUMBO all carried the Red Nose colours. That resulted in NZTR and TAB NZ each donating \$1,000 for each winner to the cause.
- On the track the day belonged to Andrew Carston who ended the dominance of Michael Pitman as the souths leading trainer with three winners to beat Michael & Matthew 42 to 40 on the premiership.

### 1. BASIS OF PREPARATION

#### Reporting entity

The Canterbury Jockey Club (Inc.) (henceforth, "the Club") is incorporated under the Incorporated Societies Act 1908. The primary objective of the Club is to promote, conduct and control thoroughbred racing and is registered with the New Zealand Thoroughbred Racing Code ("the Code") consistent with the Code's constitution. The Club is a recognised industry organisation in accordance with the Racing Act 2020.

The financial statements presented are for the Club for the year ended 31 July 2023 and were authorised for issue by the Chairman on 20 September 2023.

#### Statement of compliance

The financial statements have been prepared in accordance with the Racing Act 2020, which requires compliance with generally accepted accounting practice in New Zealand ("NZ GAAP").

As the primary objective of the Club is not towards making financial returns but the promotion, conduct and control of thoroughbred racing, it has designated itself as a notfor-profit public benefit entity (PBE) for financial reporting purposes.

The Club has elected to report in accordance with the Public Benefit Standards Reduced Disclosure Regime (PBE Standards RDR) on the basis that it is not publicly accountable and not considered large for financial reporting purposes.

The Club qualifies as a Tier 2 reporting entity as for the two most recent reporting periods it is not publicly accountable and not large (operating expenditure has been between \$2m and \$30m in the current and prior period).

#### Measurement basis

The financial statements have been prepared on a historical cost basis, and are presented in New Zealand dollars rounded to the nearest dollar which is also the Club's functional currency.

#### Going concern

The financial statements have been prepared on a going concern basis.

#### Changes in accounting policies

There have been no changes in accounting policies.

#### New accounting standards

The Club adopted the following new standards that applied for the year ended 31 July 2023:

- PBE FRS 48 - Service Performance Reporting
- PBE IPSAS 41 - Financial Instruments

#### Significant accounting judgements, estimates and assumptions

The preparation of the Club's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures. Uncertainty about these assumptions and estimates could result in outcomes that may require a material adjustment to the carrying amount of assets or liabilities affected in future periods. The judgements, estimates and assumptions are evaluated on a regular and continuing basis, including expectations of future events, to a reasonable extent to assess their implication on reported revenues, expenses, assets, liabilities and disclosures in the financial statements.

Useful lives and depreciation methods and rate for Property, Plant and Equipment are detailed at note 11.

## NOTES

### Income

The Club is exempt from New Zealand income tax pursuant to section CW 47(2) of the Income Tax Act 2007.

### Goods and Services Tax

All amounts are stated exclusive of goods and service tax (GST) except for accounts payable and accounts

Revenue is recognised to the extent that it is probable that the economic benefits or service potential will flow to the Club and it can be reliably measured, regardless of when the payment is being made. Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duty.

Revenues are classified as to whether they arise from an exchange or non-exchange transactions. An exchange transaction is one in which the Club receives assets or services, or has liabilities extinguished, and directly gives approximately equal value to another entity in exchange and includes sale of goods, rendering of services and charges for the use of the Club's assets (e.g., interest and dividends). The Club recognises revenue from exchange transactions when the revenue recognition criteria mentioned above are satisfied.

A non-exchange transaction is any other transaction not classified as exchange.

### 2.1 Race meeting revenue and expenses

Race meeting revenues comprise the amounts received or receivable for services provided and goods sold that directly relate to race meeting events conducted by the Club during the financial year. These primarily include industry distributions from TAB New Zealand and the Code and other receipts that directly relate to the Club's race meeting activities from members of the Club (aside from membership fees included in other operating income) and third parties in the form of grants and subsidies.

The Club incurred certain direct costs and expenses in conducting its race meeting days and recognises these as costs and expenses when incurred regardless of when the payment is made unless they qualify for recognition as asset. Direct costs and expenses on race meeting days are presented below excluding depreciation expenses which are included as part of other operating expenses in note 3.

Depreciation is charged at rates calculated to allocate the cost of the asset less any estimated residual value over its remaining useful life. The assets' residual values, useful lives and depreciation methods, are reviewed and adjusted, if appropriate, at each financial year end.

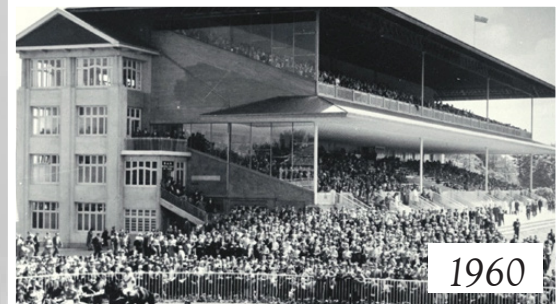
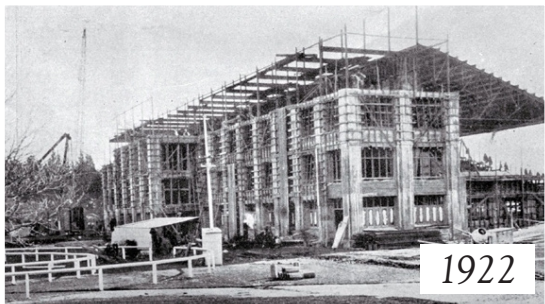

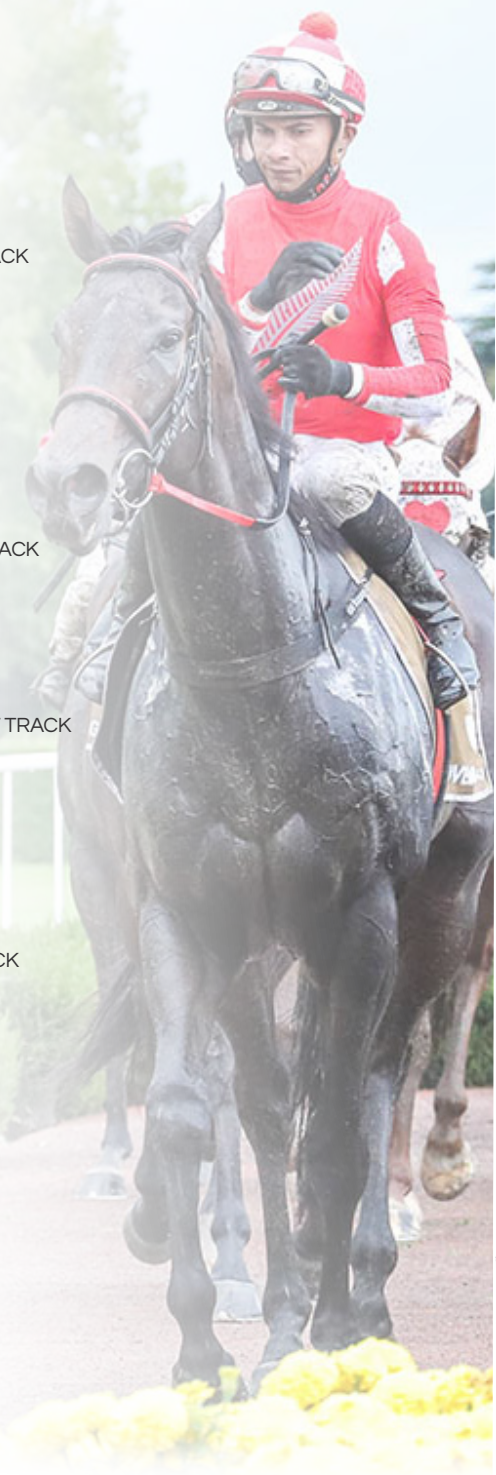
